Provider shall not be liable for any nonperformance of this Agreement by either Purchaser or the Artist/Act. Provider and Artist/Act shall hold Purchaser harmless and indemnify (including, without limitation, attorneys’ fees and costs) Purchaser against any claims, loss, liability, damage, suit or expense (collectively, “Claims”) on account of any injury or death of persons (including but not limited to, the property of the Purchaser and its agents and members and property of the Artist/Act, and its members and employees) arising out of or related to this Agreement, excluding Claims caused by the gross negligence of the Purchaser. The immediate preceding sentence shall survive the expiration or termination of this Agreement and the performance of the services under this Agreement.
